## DIVIDEND DISTRIBUTION

The Shareholders' Meeting of the Bank, which was held in Turin on 22 April 2013, approved the following proposal for the dividend distribution:

- 0.061 euro gross per savings share;
- 0.050 euro gross per ordinary share.

The aforementioned unit amounts will be paid to the shares outstanding on 20 May 2013 - date of presentation of coupon no. 36 (for savings shares) and no. 35 (for ordinary shares) - as of 23 May 2013.
