Notice is hereby given that, following the authorisations released by the European Central Bank in accordance with the regulations in force, on 30 April 2021 the plans for the merger by incorporation of Unione di Banche Italiane per il Factoring S.p.A. into Intesa Sanpaolo S.p.A. and UBI Academy S.r.l. (formerly UBI Academy Soc. Cons. a R.L.) into Intesa Sanpaolo S.p.A. were filed with the Torino Company Register, as provided for by Article 2501-ter of the Italian Civil Code.

The mergers will be approved by the Board of Directors of Intesa Sanpaolo, without prejudice, pursuant to Article 2505, last paragraph, of the Italian Civil Code, to the right of Intesa Sanpaolo shareholders holding at least five per cent of the Bank's share capital, to request, by 8 May 2021, that relevant resolutions be passed by an Extraordinary Shareholders' meeting, in compliance with Article 2502, paragraph 1, of the Italian Civil Code.
