

## DEFERRED TAX ASSETS AND DEFERRED TAX LIABILITIES

Deferred tax assets: as at 31 December 2020, deferred tax assets, recognised with regard to deductible temporary differences, totalled 13.6 billion euro (17.2 billion euro including the UBI Banca contribution) and mostly refer to fiscal losses carried forward, to the portion of tax benefits not offset in relation to adjustments to loans and provisions for risks and charges, as well as to the benefit from the realignment of the taxable value of goodwill pursuant to Article 15, paragraphs 10, 10-*bis* and 10-*ter* of Decree Law 185/2008.

Deferred tax liabilities: as at 31 December 2020, deferred tax liabilities amounted to 2.1 billion euro (2.7 billion euro including the UBI Banca contribution).
